OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery

time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. - 1) **SCOPE OF SUPPLY:** Supply of Ferric Alum Grade-4 confirming to IS-299/latest at our Jaduguda Mill Site, Unloading from truck and stacking at our stores /site stores /godown. Jaduguda Mill is 25 KM away from Tatanagar Railway station. In case of emergency, truck loaded consignment material shall be diverted to unload at Turamdih Plant which is 06 KM from Tatanagar Railway Station without any financial implication. Such information of diversion shall be intimated to the party by HOD (Stores) in mail at least seven days before the diversion of the specific lot. No amendment will be given for such diversion.
- 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will be liable to be rejected. Conditional offer will also be liable to be rejected.
- 3) **Delivery Schedule:** Delivery of material should be 4(four) equal lots in interval of 01 month starting from 15 days after getting Purchase Order. However delivery quantity in each lot may vary by 10 %.
- 4) Unloading of material at site is under the scope of the work of the supplier.
- 5) Material should be in 20-25 Kg naked solid from lumps/HDPE bags.
- 6) Test certificate should be furnished along with each consignment. Sampling of each consignment shall be done at our end with grab sampling method and shall be analyzed in our lab. Our analysis shall be treated as final and binding to both.
- 7) The analysis value will be rounded off to the nearest integer. Decimal fraction above or equal to 0.5 shall be rounded off to next integer where as below 0.5 shall be rounded off to previous integer.
- 8) **Pro Rata Penalty:-** Ferric Alum Grade-4 confirming to IS-299 supplied should be having minimum 16% (% by mass) (Al_2O_3). For supply having less than 16% (Al_2O_3) by mass content, Pro Rata deduction shall be effected on the basis of landed value of particular invoice as under:-
 - a) If the (Al_2O_3) is below 16% but up to 13% Pro Rata deduction will be effected on the basis of landed value of particular invoice.
 - b) If the (Al_2O_3) content below 13% but up to 10% double pro-rate deduction will be effected on the basis of landed value of particular invoice.
 - c) If (Al_2O_3) content is below 10% material shall be rejected. UCIL shall have the right to accept part/full quantity of material having (Al_2O_3) below 10% with triple pro - rata deduction on the basis of landed value of particular invoice.
 - d) In case of (a) & (b) supplier will not be allowed to take back of material for replacement.
 - e) Analysis report of material below 13% (Al_2O_3) will be intimated to your representative available at the site by hand or will be informed to you by e-mail within 10 working days supply. Rejected material, if any, shall be replaced within 15 days of information
- For Example:** If pro-rata value comes 15.49%, it will be rounded off as 15% & if it comes 15.50% then it will be rounded off 16%.
- 9) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.

- 13) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**
- a) **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.
 - b) **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
 - c) **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
