- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 10) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**

- a) **CONCILIATION**: Notwithstanding anything contained in this contract, any disputes or differen ces whatsoever, which are to be settled amicably between the parties with their authorized rep resentatives, shall be resolved through conciliation.
- b) **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to tim e.
- c) AMRCD: Any disputes or differences between the parties are not settled amicably with concili ation and/or Mediation, then such disputes or differences shall be resolved through Administrat ive Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating t o interpretation and application of the provisions of commercial contract(s) between Central Pu blic Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Governmen t Department(s) / Organization(s) shall be taken by either party for its resolution through AMRC D
- d) **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the v alue of the dispute and not the value of the contract which may be much higher. In all other cas es, arbitration shall not be a method of dispute resolution arising out of this contract.
- e) **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be resolv ed in civil court of law at Jharkhand only.
- 11) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related partie s in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
- 12) **Pre Contract Integrity Pact:** As per format enclosed.
- 13) **Packing of Material:** Material should be packed in 50 Kg bags.
- 14) If past performance of any bidder on supply of Barium Hydroxide at Uranium Corporati on of India Limited is not satisfactory then their offer may not be considered for Price B id Opening.

15) Sampling Collection and analysis
