If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery

time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Scope of Supply**

3. **Generic**

- 1) **Scope of work:** Supply of Ammonium Hydroxide 25% Industrial Grade, Strength: 25% v/v minimum as NH₃ (AMMONIA) technical grade under IS: 799-1985 in tankers only at our Turamdih Site. Turamdih is located 06 KM away from Tatanagar Railway station. In case of emergency, truck consignment material shall be diverted to unload at Jaduguda Plant which is 25KM from Tatanagar Railway Station without any financial implication such information of diversion shall be intimated to the party by HOD (Stores) in mail at least seven days before the diversion of the specific lot. No amendment will be given for such diversion.
- 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will be liable to be rejected. Conditional offer will also be liable to be rejected.
- 3) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
- 4) **SPLITTING OF ORDER:-**

Material shall be supplied as per our specifications only, i.e. NH₃ (AMMONIA) content 25% min.
 - a. If the NH₃ (AMMONIA) content of a consignment is below 25 %, then pro rata penalty shall be applicable for payment of the consignment.
 - b. If the NH₃ (AMMONIA) content of a consignment is below 23 %, then the supply shall be rejected right away.
- 8) **Sampling & Analysis:**
 - a. Unloading of the material shall be done by the supplier at Turamdih Mill as per the Instruction of the Section In-charge (Mill).
 - b. Before unloading, a sample shall be collected in an air-tight 500 ml bottle and sent to UCIL laboratory for analysis along with the tag of the Invoice Number and date.
 - c. The tanker shall be unloaded only after the UCIL lab result.
 - d. No re-sampling or re-analysis shall be entertained.

e. Analysis report of UCIL laboratory shall be treated as final and binding for the sample collected at the time of unloading.

f. 0.5 and above % will be rounded off to the next integer.

For Example : If value comes to 24.49%, it will be rounded off 24% & if it comes 24.50% than it will be rounded of 25%.

9) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**

- a) **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.
- b) **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c) **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d) **ARBITRATION:** Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e) **JURISDICTION:** If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.

Note:

- 1) Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.
- 2) As staggered delivery schedule and Pro-rata deduction clause given in the bid document, hence offline calculation of LD and pro-rata penalty will be done by Paying authority during the time of making payment to the supplier.
- 3) PUC certificate of Pollution Control, if applicable should be submitted along with the supply of materials.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
