- IV) The supplied media must be guaranteed against any kind of manufacturing defects/damages like rupture of zipper/clippers, breakage of pintle wire, holes developed under operation due to

vacuum, elongation beyond a tolerance limit of 1% ----for 2000 hrs. From the date of installation or one year from the date of receipt of the material whichever is earlier for normal operating conditions as mentioned earlier. Such things whenever noticed shall be informed to the party immediately if it happens within the guarantee period. Party shall make their own arrangement to visit at UCIL, Jaduguda for a joint inspection with UCIL technical team within 10 working days of receiving the information by e-mail/ FAX. - iii) **Performance Testing procedure:** 300 ml of available plant slurry (55%-60% w/w solid as per duty conditions mentioned) shall be taken in 1 liter measuring cylinder (Make borosil) and 25 ml of natural guar gum solution shall be added and then the mixed slurry is allowed to pass through a Buchner funnel arrangement (i.e. offered filter fabric sample fitted in a Buchner funnel operating under a vacuum of 500-550 mm Hg. The filtration time for achieving complete dry top of the filtered cake shall be recorded. The offered sample shall meet the specified filtration time in the selection criteria for further evaluation of the submitted offer. Samples not meeting the specified selection criteria shall be rejected. Dimension of Buchner funnel is (ID=9.5 cm, H = 13 cm)
- iv) **Selection criteria:** The complete dry top filtration time of 300 ml of slurry with 55% 60% (w / w) solids having a natural guar gum (0.05% w/w strength) dose of 25 ml shall come in the range of 30 seconds (\pm 5 seconds tolerance). The sample of fabricating filtered cake dry top filtration time more than the above-mentioned range will be rejected. Also cake dry top filtration time less than the above-mentioned range will be accepted and qualified.
- v) P.O shall be placed for the same material as qualified offered sample as supplied with the technical bid against said NIT for evaluation only.
- vi) Only one sample shall be allowed from each party for testing. If any party supplies more than one sample party must clearly mention which is to be tested in our lab.
- vii) Testing report of UCIL shall be treated as final and binding.
- viii) Test report of the filtration test shall be given to the party only upon written request. The report shall carry only result of the sample supplied by the concerned party only. Report of other bidder's samples shall not be given at all.
- ix) Each consignment supplied against PO shall be tested against the original sample provided during bid evaluation for acceptance of the material at UCIL. Random sample shall be taken for

testing and comparison from the bulk supply. Bulk supply shall meet the filtration time taken by original sample with a tolerance in filtration time of plus/minus 5 seconds for acceptance of the material.

8) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**

- a. **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.
- b. **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c. **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION:** Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e. **JURISDICTION:** If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.

- 2) PUC certificate of Pollution Control, if applicable should be submitted along with the supply of materials.
