- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

10. Generic

- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

(c) is not applicable, the parties ma y go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disput es is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of t he dispute and not the value of the contract which may be much higher. In all other cases, arbitrat ion shall not be a method of dispute resolution arising out of this contract.
- e. **Jurisdiction**: If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.
- 2) Guarantee/warranty: Material should be Warranted for the period of 12 months from the date of r eceipt , inspection and acceptance of material at our store.
